Insurers are increasingly embedding sustainability in their strategies, business models and operations in response to a combination of regulatory, economic, societal and climate-related drivers.

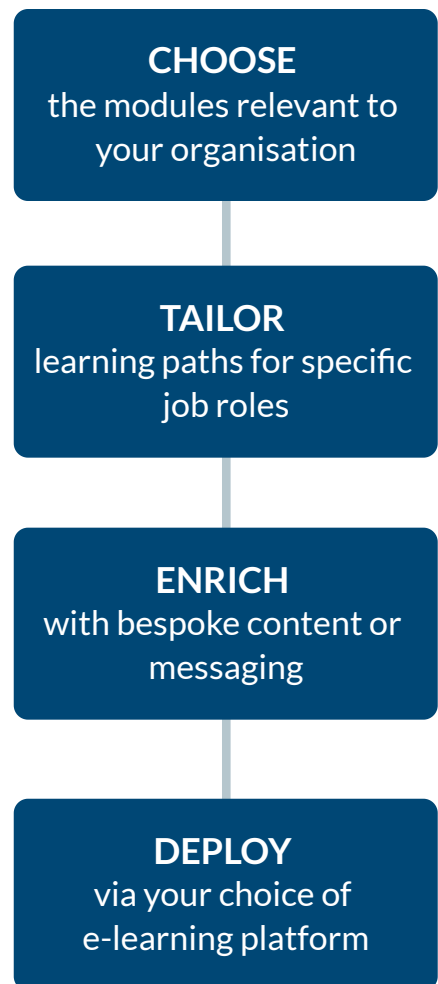

2. Tailor learning paths

Our platform enables you to **design learning paths** that makes sense for your employees:

3. Enrich the content

Course content is designed to meet the sustainability training needs of insurance companies. However, you may wish to enrich the core content with bespoke company-specific information or messaging aligned with your organisation's approach and objectives.

For an additional fee, we can script, produce and incorporate this content into your learning programme. This could include, for example:

- **Bespoke modules** focusing on additional topics/technical information.

4. Deploy and scale

Employees can access content via the **Better Insurance Network e-learning platform**.

As an organisation, you will be given your own dedicated part of the platform, ring-fenced from other companies and white-labelled to align with your brand. The platform offers extensive reporting and company representatives can be added as administrators.

The annual subscription is charged based on the number of learners accessing the platform.

For larger organisations, our **Enterprise** licence plan allows you to host the course content (including ongoing updates and additions) on your own/preferred learning platform for a fixed annual fee. This enables you to scale the training across your organisation while controlling costs, employee data, learning paths and reporting.
